Item I The meeting was called to order by Board President Mark Drymalla at 6:12 pm.

Item II Prayer was given by Nikki Screws.

Item III The votes from the May 8th election were canvassed by Trudy Hancock.

Item IV Trudy Hancock certified the May 8th election.

Item V The Oath of Office was administered by Notary Public Rachel Bell to the newly elected officers of the School Board, Donald Johnson, Mark Drymalla, and David Kujawa. The newly elected trustees signed their statement of officeholder as duly elected officers. Gary Johnson showed up at 6:20 pm.

Item VI A motion was made by Michelle Yezak to nominate David Kujawa for President of the School Board. A motion was made by Gary Johnson to nominate Mark Drymalla as President of the School board. A motion was made by Randy Yanowski and seconded by Gary Johnson to cease nominations. This motion carried by a vote of 7-0. Mark Drymalla received 5 votes and David Kujawa received 2 votes. The nomination for Mark Drymalla to be appointed President of the School Board carried by a vote of 5-2.

A motion was made by Randy Yanowski to nominate Gary Johnson for Vice-President of the School Board. A motion was made by Michelle Yezak to nominate David Kujawa for Vice-President of the School Board. A motion was made by Randy Yanowski and seconded by David Kujawa to cease nominations This motion carried by a vote of 7-0. Gary Johnson received 4 votes and David Kujawa received 2 votes with Donald Johnson abstaining.

The nomination for Gary Johnson to be appointed Vice-President of the School Board carried by a vote of 4-2-1.

A motion was made by David Kujawa to nominate Michelle Yezak for Secretary of the School Board. A motion was made by Gary Johnson to nominate Nikki Screws for Secretary of the School Board. A motion was made by Randy Yanowski and seconded by Gary Johnson to cease nominations. This motion carried by a vote of 7-0. Michelle Yezak received 3 votes and Nikki Screws received 4 votes. The nomination for Nikki Screws to be appointed Secretary of the School Board carried by a vote of 4-3.

Item VIII A motion was made by Gary Johnson and seconded by Randy Yanowski to adjourn the meeting. This motion carried by a vote of 7-0. The meeting was adjourned at 6:35 pm.
